- 1) Serve as a probationary apprentice for a period of 1 year (1500 hours of on the job training)
- 2) Serve a 5 year apprenticeship including the probationary period (7500 hours of on the job training)
- 3) Report for work on a regular basis
- 4) Provide for your transportation to and from the jobsite
- 5) Work under a journeys workers supervision on the jobsite and perform duties satisfactorily
- 6) Attend related training classes on a regularly and maintain an acceptable average in those classes
- 7) Purchase text and materials for use in related training classes as required
- 8) Abide by all rules and regulations of the Joint Apprenticeship and Training Committee
